

**AFFIDAVIT**

I, ..... , son / daughter / wife of ..... , resident of ..... the deponent, do solemnly affirm, state and pledge on oath the following in connection with my application for grant of admission in **AMOGHA Institute Of Professional and Technical Education**, Meerut Road, Ghaziabad, for B.Sc. Nursing / GNM course for the academic session .....

1. That I am fully conversant with the facts of the submitted application and the attached original educational documents (if) submitted by me, and the caste, domicile and migration certificate etc., and the submitted post dated cheques, and certify that they are true and correct and have not been tampered.
2. That by virtue of my submitted application for B.Sc. Nursing / GNM course for the academic session ....., I hereby understand that I have reserved my seat in the institute for the said course for its entire duration and shall be fully liable to meet all the financial obligations towards the institute till the completion of my course and shall not cancel/withdraw my admission at any time before completion of the course.
3. That I am fully aware of the rules and regulations of the CCS University, UP State Medical Faculty and INC, prevalent at the time of my admission and my admission is provisional subject to change in any such rules and regulations. And I shall not hold the institute responsible for any consequences thereof due to any changes in them.
4. That I have read and understood the rules and regulations of the institute and shall abide by them. I shall also comply with the dress code of the institute. I have also fully understood the provisions contained in the UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009, in particular, perused clause 7 and clause 9.1 of the Regulations and am fully aware of the penal and administrative action that is liable to be taken against me in case I am found guilty of or abetting ragging, actively or passively, or being part of a conspiracy to promote ragging. I further affirm that, I will not participate in or abet or propagate through any act of commission or omission that may be constituted as ragging under clause 3 of the Regulations. And, if found guilty of ragging, I am liable for punishment according to clause 9.1 of the Regulations, without prejudice to any other criminal action that may be taken against me under any penal law or any law for the time being in force.
5. That the fees once deposited to the institute shall not be demanded back by me or refunded back to me in part or full if I cancel or withdraw my admission for any reason whatsoever or if my admission is cancelled by the CCS University or UP State Medical Faculty or INC or the Institute due to change in their rules and regulations or due to any discrepancy in the information, facts and/or document(s) submitted by me or due to any disciplinary action against me or due to any other reason whatsoever and I shall not take any legal action against the institute for such an event.
6. That if my admission is cancelled due to any reason mentioned in clause 5 above, or if I withdraw / cancel my admission from the institute at any time before completion of the entire course, then I shall be liable to pay the full fee of the institute for the entire course before withdrawing / cancelling my admission and the institute shall have the full right to claim the fees for the balance period of completion of the course legally or otherwise. And in case of such an event of cancellation/withdrawal of my admission from the institute at any time before completion of the entire course, the institute shall have the full right to use my post dated cheques and scholarship amount (if received) towards payment of the balance fee of the entire course and also, shall have the right to retain all my original documents (submitted by me at the time of admission) till the time the balance fee of the entire course is paid/cleared by me to the institute.
7. That the fee paid by me to the institute at the time of admission is provisional and is subject to revision and does not include the examination and other university and institute fees. And I shall be liable to pay the examination and other university and institute fees immediately as and when required and demanded by the institute alongwith increase (if any) in the course fees of the institute, else I could be barred to attend any further classes in the institute and/or appear for the final examination of the university or the faculty. And the sole responsibility of the consequences thereof shall be mine and I shall not take any legal action against the institute for any consequences thereof.
8. That in the event of non- payment of the fees by me to the institute as mentioned in clause 5,6 and 7 above, then the institute and any of its authorities shall have the right to forfeit the scholarship fees / fee reimbursement received by the institute on my behalf from the department of social welfare or from any other source towards my fees / scholarship amount and I shall have no right / claim on the said amount irrespective of the caste or creed.
9. That I shall not appear for any other examination / degree during the session ..... and shall not be working anywhere or attending full time classes elsewhere at the duration of my present Nursing course and shall attend the classes full time at AMOGHA Institute as per the institute time table maintaining at least 75% attendance in the theory classes and 100% attendance for clinical practice/practical classes, failing which I may be debarred to appear for final examination conducted by the university or even expelled from the institute.
10. That if any of the facts and/or documents submitted by me are found to be incorrect or faulty, or in the event of non-compliance any of the rules and regulations and norms and standards or any other conditions laid down/prescribed by the CCS University, UP State Medical Faculty, INC or the Institute or in the event that I withdraw my admission from the institute, then the institute or any of its authorities shall will be free to take all necessary measures for effecting cancellation / withdrawal of my admission, without consideration of any other issue, and that all liabilities arising out of such a cancellation / withdrawal , including those mentioned in the clause 5,6 and 7 above, would solely be that of myself/mine without demanding refund or return of all the fees submitted to the institute for the same from time to time, and I shall not take any legal action against the institute for such an event, and the institute shall have the right to retain all my original documents (submitted by me at the time of admission) till the time the balance fee of the entire course is paid/cleared by me to the institute.
11. That no inquiry is pending against me in the court of law or with any college/police/ district or state government authority. I hereby declare that I have not been expelled or debarred from admission in any institution in the country on account of being found guilty of, abetting or being part of a conspiracy to promote, ragging; and further affirm that, in case the declaration is found to be untrue, I am aware that my admission is liable to be cancelled.
