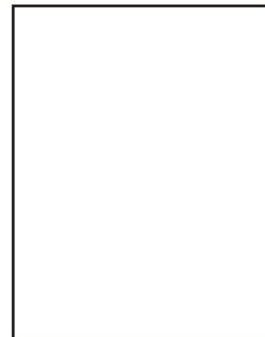

- That if any of the facts and/or documents submitted by me are found to be incorrect or faulty, or in the event of non-compliance any of the rules and regulations and norms and standards or any other conditions laid down/prescribed by the CCS University, UP State government, NCTE, INC or the Institute or in the event that I withdraw my admission from the institute, then the institute or any of its authorities shall will be free to take all necessary measures for effecting cancellation / withdrawal of my admission, without consideration of any other issue, and that all liabilities arising out of such a cancellation / withdrawal, including those mentioned in the clause 6. above, would solely be that of myself/mine without demanding refund or return of all the fees submitted to the institute for the same from time to time, and I shall not take any legal action against the institute for such an event.
